**3. SELECTION TIMELINE**

SECTION	PERIOD	REMARKS
1	January - July 2026	The list of athletes nominated by SSA to SNOC for the Asian Games will be announced by 31 July 2026.

3.1. An appeal period of 3 days will be given after each announcement. The appeals will be reviewed by the SSA Appeals, Grievances and Discipline Sub-Committee or any other committee as appointed by SSA.

- i. Chairman – 1st Vice President
- ii. Honorary Treasurer
- iii. Assistant Honorary Treasurer



3.2. This committee, comprising the 1st Vice President, Honorary Treasurer, and Assistant Honorary Treasurer, will make its recommendations to the SSA Council for approval, without being involved in the selection of the name list.

- i. All committee members must disclose any conflict of interest (e.g., relationships with players, coaches, or clubs).
- ii. Members with conflicts of interest must recuse themselves from relevant decisions (e.g. voting, participating in, or influencing the selection process).

3.3. SSA will be guided by the ISSF Rules and Regulations.

#### 4. NUMBER OF SHOOTERS SELECTED

4.1. SSA will select the final team up to the maximum number for individual events.

#### 5. SELECTION SYSTEM

5.1. **Priority:** The spaces will be filled BY RANK, using 3 best scores from 4 selection shoots listed below. Athletes must have at least two scores that meet the Minimum Qualification Standard (MQS) as stated in 5.5.

5.2. **Remaining Spaces:** Any remaining spaces will be filled BY RANK, using 3 best scores from 4 selection shoots listed below. Athletes must have at least one score that meet the Minimum Qualification Standard (MQS) as stated in 5.5.

5.3. All participants who qualify for the finals must compete in the finals, or their qualification scores will be invalidated.

#### 5.4. **Asian Games 2025 – Selection Competitions (April to July 2026)**

SNOC's athlete selection assessment prioritizes performance outcomes from SSA-endorsed international competitions sanctioned by International and/or regional controlling bodies. **Results from PRIMARY competitions constitute the principal evaluation criteria for Asian Games selection decisions. Local competition results may be submitted by SSA as supplementary evidence but carry reduced weighting in the overall assessment process.**

**PRIMARY Selection: Overseas Competitions (subject to athlete qualification and SSA endorsement)**

5.7. Athletes must be Singapore Citizens, and should not be holding dual citizenship if they are above 22 years old, at the time of nomination.

5.8. Pursuant to the Olympic Charter (By laws to Rules 27 and 28, paragraph 2.1), "Selection shall be based not only on the sports performance of an athlete, but also on his ability to serve as an example to the sporting youth of his country."

#### 5.9. IN THE EVENT OF A TIE

In the event of a tie, a shoot-off will be organised.

## **6. THINGS TO NOTE**

6.1. The name list to be submitted to the SNOC will be decided by the SSA Council, excluding members of the Appeal Committee, with advice from the SSA High Performance Department.



- 6.2. The final team list will need to be approved by the Singapore National Olympic Council (SNOC). **Please note that SNOC's selection mark is set at a minimum of 6<sup>th</sup> placing score of the 2022 Asian Games.**
- 6.3. SSA may include additional selection competitions with prior notice, depending on changes in the competition calendar locally or internationally.
- 6.4. Should the Asian Games be postponed for more than 90 days, SSA reserves the right to re-select the team.
- 6.5. In addition to the above selection criteria, the following "qualities" of the athletes will be taken into consideration:
- Attitude and behaviour towards coaches, teammates, fellow athletes, officials and sports administrators, whether in relation to sporting matters or otherwise.
  - General conduct and character which may affect the reputation, image, values or best interests of the athlete or the sport.
  - Past disciplinary record;
  - The Level of Commitment and Attendance refers to an athlete's dedication to consistently attending training, meetings, and competitions. It involves following the training program, maintaining focus, and supporting the team. Commitment also includes mental resilience, taking responsibility for performance, and managing personal responsibilities. High commitment and regular attendance are essential for achieving success and continuous progress
  - Ability to demonstrate team spirit and work well with teammates and officials
- 6.6. In consideration of the performance and "qualities" of athletes, the selectors may at their discretion give consideration to extenuating circumstances. For this purpose, "extenuating circumstances" mean an inability of the athlete to compete in and/or attend competitions, training or other required attendances arising from:
- Injury or illness.
  - Equipment failure.
  - Travel delays.
  - Bereavement; and
  - Such other circumstances as the selectors may consider to be relevant.
- 6.7. For athlete replacements after Entry By Name, the said replacement athletes must have been nominated from the long list and selected by SNOC for the respective event. Athlete replacement after the Entry By Name deadline is also subject to the approval of the Games Organising Committee in accordance with their late athlete replacement policy.
