3. SELECTION TIMELINE

SECTION	PERIOD	REMARKS
1	March - May 2025	The list of athletes nominated by SSA to SNOC for the SEA Games will be announced by 30th Jun 2025.

- 3.1. An <u>appeal period of 3 days</u> will be given after each announcement. The appeals will be reviewed by the SSA Appeals, Grievances and Discipline Sub-Committee or any other committee as appointed by SSA.
 - i. Chairman 1st Vice President
 - ii. Honorary Treasurer
 - iii. Assistant Honorary Treasurer

- 3.2. This committee, comprising the 1st Vice President, Honorary Treasurer, and Assistant Honorary Treasurer, will make its recommendations to the SSA Council for approval, without being involved in the selection of the name list.
 - i. All committee members must disclose any conflict of interest (e.g., relationships with players, coaches, or clubs).
 - ii. Members with conflicts of interest must recuse themselves from relevant decisions (e.g. voting, participating in, or influencing the selection process).

4. NUMBER OF SHOOTERS SELECTED

4.1. SSA will select the final team up to the maximum number for individual events.

5. SELECTION SYSTEM

- 5.1. Athletes ranked according to the average of 2 best scores from the 3 selection shoots.
- 5.2. The Top 5 ranked athletes will be selected to form the teams for both events. For Compak, the team will consist of 3 athletes with 2 reserves, while for Sporting, the team will include 4 athletes with 1 reserve. Please note that the selection of reserves is subject to Singapore National Olympic Council (SNOC) approval for participation in the competition.
- 5.3. Selection shoots to be open to accredited shotgun shooters from all SSA constituent clubs.

5.4. SEA Games 2025 - Selection Competitions (March to May 2025):

While SSA may submit results from local competitions as additional supporting data for consideration, SNOC primarily evaluates performance data points from international competitions sanctioned by International and/or regional controlling bodies in its assessment.

- 5.6. Athletes must be Singapore Citizens, and should not be holding dual citizenship if they are above 22 years old, at the time of nomination.
- 5.7. Pursuant to the Olympic Charter (By laws to Rules 27 and 28, paragraph 2.1), "Selection shall be based not only on the sports performance of an athlete, but also on his ability to serve as an example to the sporting youth of his country."

5.8. IN THE EVENT OF A TIE

In the event of a tie, a shoot-off will be organised.

6. THINGS TO NOTE

- 6.1. The name list to be submitted to the SNOC will be decided by the SSA Council, excluding members of the Appeal Committee, with advice from the SSA High Performance Department (comprising Mr. Edmund Goh and Ms. Karen Teo).
- 6.2. The final team list will need to be approved by the Singapore National Olympic Council (SNOC). Please note that SNOC's selection mark is set at a minimum of 3rd placing score of the 2023 SEA Games. As Shooting was not featured at the 2023 SEA Games, the SSA will use the average score of the 3rd-placing team from the top 3 Southeast Asian countries at the 2025 7th FITASC Asia Championship in Thailand for athlete nomination.
- 6.3. SSA may include additional selection competitions with prior notice, depending on changes in the competition calendar locally or internationally.
- 6.4. Should the SEA Games be postponed for more than 90 days, SSA reserves the right to re-select the team.
- 6.5. In addition to the above selection criteria, the following "qualities" of the athletes will be taken into consideration:
 - Attitude and behaviour towards coaches, teammates, fellow athletes, officials and sports administrators, whether in relation to sporting matters or otherwise.

- General conduct and character which may affect the reputation, image, values or best interests of the athlete or the sport.
- · Past disciplinary record;
- The Level of Commitment and Attendance refers to an athlete's dedication to consistently attending training, meetings, and competitions. It involves following the training program, maintaining focus, and supporting the team. Commitment also includes mental resilience, taking responsibility for performance, and managing personal responsibilities. High commitment and regular attendance are essential for achieving success and continuous progress.
- Ability to demonstrate team spirit and work well with teammates and officials.
- 6.6. In consideration of the performance and "qualities" of athletes, the selectors may at their discretion give consideration to extenuating circumstances. For this purpose, "extenuating circumstances" mean an inability of the athlete to compete in and/or attend competitions, training or other required attendances arising from:
 - Injury or illness.
 - Equipment failure.
 - Travel delays.
 - Bereavement; and
 - Such other circumstances as the selectors may consider to be relevant.
